Price-Evaluation (criterion 4)

Price will be assessed according to the following model: The proposal that submitted the lowest price achieves maximal price points. The other submitted proposals achieve points according to percentage difference between the individual price and the submitted proposal with the lowest price.

Price point = (Lowest price / Individual price) * Max point price criterion
