## Minors (under 18 years) - Kenya

Please note: Checklist applicable for the purpose of your travel need to be fulfilled, in addition to this checklist.

Documents required for minors	Check
Application for Schengen Visa –application form completed and signed by custodian.	
Passport	
• Original passport valid for travel to Sweden. The passport validity must exceed the planned	
stay in the Schengen Area with at least three months. The passport must have been issued	
within the last ten years.	
Complete photocopies of original passport, except blank pages.	
• Previous passport in original if a new passport has been issued within the last year.	
Proof of visa fee payment (bank deposit slip) or proof of fee exemption (if applicable).	
Individual modical travel incurance valid in all Schengen countries for the duration of the stay	
Individual medical travel insurance valid in all Schengen countries for the duration of the stay,	
covering the costs of at least EUR 30,000 which could arise as a result of emergency medical	
assistance, emergency hospitalization or medical repatriation.	
1 color photo not more than 6 months old, passport size (45 mm x 35 mm), full face and taken	
against a light background.	
Children under 12 years are exempted from submitting fingerprints. Applicants who submitted	
fingerprints in a previous application and were granted a Schengen visa within the last 59	
months they are exempted from resubmitting a new fingerprint.	
Copy of flight ticket or flight reservation including return flight.	
For non-Kenyan citizens: Kenyan proof of residence or proof of legal stay in any other country	
within the Embassy's coverage area, valid for at least 3 months from the date of intended	
departure from the territory of the Member States.	
Copy of birth certificate.	
Copy of both parents' ID -cards or passports.	
Certified bank statement (covering the last three months) of parent(s)/guardians(s)/sponsors.	
Written consent letter from both parents certified by notary if the child is travelling alone, or	
from the parent that is not accompanying the child when travelling. The letter should include	
the parent(s)' telephone and e-mail contacts.	
If either one of the parents is absent or deceased, this must be evidenced by the information on	
the birth certificate or a death certificate or a Court Order for the custody.	
If the legal guardian is someone other than the biological parent as stated in the birth	
certificate, a custody order must be submitted proving the legal guardianship.

A letter from school containing the minor's name, name of parents, grade, number of years at A	
letter from the school containing the child's name, name of parents, grade, number of years at school, dates of school holidays, contact details, date and name of school representative.	

If the child is travelling with a group: a complete list of names of all group members travelling	
and name of person in charge of the group.	

## Please note:

- Applications can be submitted up to 6 months before the intended travel and not less than 15 calendar days
  before the intended travel. Please note that the days are counted from when the Embassy has received the
  application and not when the application was submitted at VFS Global. The transportation time between the
  application centers and Nairobi is published on the website of VFS Global.
- The handling time may take up to 15 days (counted from when the Embassy has received a <u>complete</u> application) but may take up to 45 days, if verification of documents or an interview needs to be conducted or such.
- All submitted documents must be in English or in Swedish.
- An interview may be required at the Embassy or by phone.
- Further information or documentary evidence in support of your application may be required.
- All documents are mandatory. If documents are not submitted at the time of application, they may be sent
  within 2 working days to the following email address: <a href="mailto:ambassaden.nairobi-visum@gov.se">ambassaden.nairobi-visum@gov.se</a>. If mandatory
  documents, as stated in the checklists, are not received within the stipulated time, the Embassy will make
  a decision based on existing documentation.
