

Power of attorney / 授权委托书

Use this power of attorney if you are going to move to some one, work, study or visit Sweden and you want someone to represent you. You can revoke your power of attorney at any time. / 如果您打算提交赴瑞留学, 工作, 家庭团聚或是探访居住许可申请, 并授权某人代理您的申请, 请使用此授权委托书。您也可以在任何时候撤消您的授权。

Please note! The power of attorney should be given to a specific person and cannot be issued to a company or likewise. For verification purpose the Embassy may contact you for additional information about the assigned person. / 请注意: 您应当授权给特定的人而非公司或者类似机构。为核实身份所需, 使馆将与您联系以了解受托人更多信息。

My representative also has power of attorney to represent me in a case where I represent a child under 18 years. / 我的代理人也被授权办理我所代理的18岁以下未成年人的相关事宜。

This power of attorney is valid until I revoke it. If I do not revoke it, this power of attorney ceases to apply when the matters the power or attorney related to have been fulfilled. / 此授权书在我撤销授权前一直生效。如未撤销授权, 在授权事宜完毕时, 该授权书将不再适用。

- A copy of the ID page of your passport. / 您的护照身份页复印件
- Original ID card and/or passport of your representative. / 代理人的身份证原件及/或者护照原件

Additional documents needed when it comes to a child / 涉及未成年人时还须携带以下材料:

- A copy of the child's passport. / 未成年人护照复印件
- A copy of the child's birth certificate. / 未成年人出生证复印件
- An official document (copy or original) showing who the legal guardian of the minor is, if someone other than the minor's parent/s. / 如果未成年人的父亲/母亲非其法定监护人, 则须提供孩子监护权的正式文书(复印件或者原件)
