How to read a visa sticker

If you find that the information on the visa sticker is incorrect, contact the Embassy immediately.

DURATION OF STAY.....DAYS indicates the number of days you may stay in the Schengen area. The days should be counted from the date you enter the Schengen area to the date you exit the Schengen area, i.e. both days included.

The period of time between "**FROM ...UNTIL**" is usually longer than the number of days printed in the "**DURATION OF STAY**" field. The difference in period is meant to give you flexibility to plan your entry into and exit from the Schengen area, but your stay in the Schengen area must never exceed the exact number of days in the "**DURATION OF STAY ...DAYS**" field. **No matter how many days you have stayed in the Schengen area, you must leave no later than the date printed in the "UNTIL" field.**"

Number of entries: 01: Allows for a single entry into the Schengen area.
 02: Allows for two entries.
 MULT: Allows for multiple entries.

Type of visa: This indicates the purpose of your visit (e.g., Type C for short-stay, Type D for long-stay).

Valid for: This specifies the geographical area your visa is valid for. If it lists a country's initial (like SE for Sweden), it might only be valid for that country. If it lists multiple country initials, it's valid for those countries. "SCHENGENSTATER" means the visa is valid for all Schengen states.

Note: *The possession of a visa does not confer an automatic right of entry into Schengen. When crossing the border, you must fulfil the requirement in the border code. Therefore, you should always carry supporting documents showing the purpose of your visit.*
