Special charges

In the case of services performed outside the mission's premises, applicants shall also pay for travel expenses and, in the case of measures performed outside the locality where the mission is situated, hotel and per diem expenses. If the service is performed by an official of an Embassy or a Career Consulate, payment shall be made in accordance with the norms applying to official journeys. An Honorary Consul or official is entitled to reasonable compensation for living expenses.
