## Poland

- Amount if stay is shorter than 4 days: 300 PLN

  - NB: A foreigner entering the territory of Poland who
    - a) Is a participant in a tourist event, a youth camp or sports event = 20 PLN/day, min 100 PLN
    - b) Has had the cost of the stay in Poland paid = 20 PLN/day, min 100 PLN
    - c) Comes to a treatment and sanatorium facility = 20 PLN/day, min 100 PLN
    - d) Is a participant in the program enabling to perform holiday work on Polish territory, which is not the main purpose of their stay, governed by an international agreement to which Poland is a party = 20 PLN/day, min 100 PLN
    - e)
- Amount to cover cost of the return journey or journey to third country
  - 1) 200 PLN, if they came from a country neighboring Poland
  - 2) 500 PLN, if they came from a Member state of the EU other than neighboring Poland
  - 3) 2 500 PLN, if they came from a country that is not a Member state of the EU
